



EMERGENCY PROCLAMATION

06-1-2020

WHEREAS, the City's first Emergency Proclamation was approved and issued on Friday, March 20, 2020 and is hereby terminated; and

WHEREAS, the Governor of the State of Oklahoma on Wednesday, April 22nd, announced his "Open Up and Recover Safely" (OURS) Plan, a three-phase approach to open Oklahoma's economy; and

WHEREAS, the City's First Amended Emergency Proclamation was approved and issued on Thursday, April 23, 2020, implementing Part 1 of Phase 1 of the Governor's "Oklahoma's Open Up and Recover Safely Plan"; and

WHEREAS, the City's Second Amended Emergency Proclamation was approved and issued on Thursday, May 1, 2020, implementing Part 2 of Phase 1 of the Governor's "Oklahoma's Open Up and Recover Safely Plan"; and

WHEREAS, the City's Third Amended Emergency Proclamation was approved and issued on Thursday, May 14, 2020, implementing Phase 2 of the Governor's "Oklahoma's Open Up and Recover Safely Plan" effective May 15th; and

NOW, THEREFORE, I, EDDIE ODLE, THE MAYOR OF THE CITY OF THE BLANCHARD, OKLAHOMA, BY THE POWERS INVESTED IN ME BY OKLAHOMA STATE LAW AND MUNICIPAL CODE, AND ON BEHALF OF THE CITY COUNCIL, DO HEREBY REPEAL ALL PREVIOUS PROCLAMATIONS AND ORDER THE FOLLOWING NEW GUIDELINES WITH THE OPENING OF REMAINING BUSINESSES EFFECTIVE IMMEDIATELY, AS FOLLOWS:

SECTION I: The City of Blanchard encourages all of its businesses to reopen as soon as possible, in order to stimulate the local Blanchard economy while maintaining safe practices.

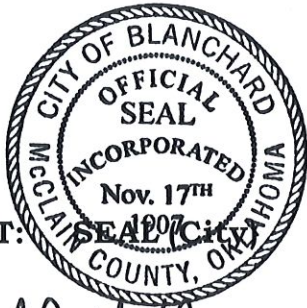
SECTION II: The City of Blanchard suggests that all residents continue to maintain safe practices to avoid contracting and/or spreading COVID-19.

SECTION III: The City of Blanchard intends to follow the remaining guidelines for other types of businesses and public access to other facilities as outlined in the Governor's Phase 3 of the OURS plan.

SECTION IV: This Proclamation shall become effective Monday, June 1, 2020, upon the signature of the Mayor.

SECTION V: Further, this Proclamation is subject to amendment if conditions so warrant.
